Subject: Final 2017-19 State Capital Budget

After months of negotiation, lawmakers have reached a deal on the rural water rights debate, known as the Hirst decision, which had stalled the passing of a capital budget in the 2017-19 legislative session. With that compromise reached, the proposed state capital budget, <u>Substitute SB 6090</u>, was passed off the Senate and House floors late Thursday night and signed by the Governor on Friday. The Governor vetoed language that would have required a Higher Education and State Facility Financing Study. This change had no effect on the UW's capital appropriation.

The final 2017-19 capital budget replicates the final bipartisan proposal that was reached, but not passed, in July 2017. The budget includes \$82.5 million in new state funding for capital projects, along with \$70.8 million in appropriations from the UW Building Account, and \$1 million from the State Toxics Control Account for soil remediation at the UW Tacoma campus. The budget closely mirrors the Governor's capital proposal, but with \$3 million less from the UW Building Account for seismic upgrades. Both the Governor's proposal and the final 2017-19 capital budget are outlined in the table below and compared to the UW's original and revised 2017-19 capital budget requests.

The final capital budget also includes language from the Governor's proposal that allows the UW to reimburse itself for internal resources and loans that were used to continue critical operations in the absence of a capital budget. The Governor vetoed language that would have required a Higher Education and State Facility Financing Study. This change had no effect on the UW's capital appropriation.
